## General Exhibition Conditions

1. The invoice sent is also the stand confirmation and must be paid immediately. The reservation is valid once payment has been made. The exhibition management reserves the right to dispose of the stand elsewhere if the payment deadline is not met and following a reminder. By signing the registration form, the exhibitor recognises the General Exhibition Terms and Conditions. Verbal agreements are not permitted and must be made in writing.
2. The rental contract is legally binding immediately after signing. In the event of cancellation up to 6 weeks before the start of the exhibition, 50% of the stand rental fee must be paid; in the event of cancellation after this date, the full stand rental fee must be paid.
3. The organisation of the stand layout and the arrangement of the stands is carried out exclusively by the organiser and will be carried out after receipt of all registrations. The organiser reserves the right to relocate stands and advertising spaces to other locations in order to improve the overall appearance. A rent reduction cannot be claimed for this. The organiser is also entitled to exclude individual products from the exhibition.
4. The organiser decides on the respective admission of an exhibitor. The authorisation granted may be revoked in the event of violations or changes to the requirements. The exhibition management reserves the right to reject applications for organisational reasons. Exclusion of competition is not guaranteed. Legal recourse is excluded.
5. The exhibitor undertakes to keep his stand open and staffed for the entire duration of the exhibition. Opening hours from 09:00 to 18:00, closing time 19:00 - subject to change! Every stand holder is required to keep their stand clean and tidy at all times. A cleaning service is not provided for the individual stands. Stands must be left swept clean at the end of the event and all items brought onto the stand (cardboard, packaging, etc.) must be disposed of by the tenant. Failure to do so will result in cleaning and disposal costs being charged.
6. Each exhibitor and his staff will receive an exhibitor pass for the trade fair, which is non-transferable. Failure to do so will result in confiscation. The passes are issued exclusively by the exhibition management.

7. The delivery of goods and stand construction must be completed 1 hour before the start of the exhibition. It is not permitted to bring visitors or other persons into the hall before the start of the exhibition. The stewarding service may expel such persons from the hall. Stand construction assistants are an exception. They must collect a special pass at the accreditation desk and may remain on the exhibition grounds for the loading and unloading of stands and for the duration of the stand construction period.
8. Stand construction is possible from Tuesday 27 May to Wednesday 28 May 2025, from 08:00 to 20:00. Exhibition stands should not exceed a height of 2.50 metres. Heights exceeding this are subject to authorisation. Stands must be stable and due care must be taken, particularly with regard to health and safety. The stand owner is solely liable for any damage.
9. The exhibits must not protrude into the aisles.
10. The rented stand space may not be passed on to third parties or exchanged in whole or in part without the consent of the exhibition management. Failure to do so may result in exclusion from the exhibition without reimbursement.
11. If a stand is rented by several exhibitors, each shall be jointly and severally liable.
12. If it is not possible to hold the exhibition in an orderly manner, the organiser is entitled to cancel the exhibition or to shorten the duration of the exhibition. Claims for damages can only be asserted if gross negligence on the part of the exhibition management can be proven. The risk of force majeure or vandalism, which could lead to the cancellation of the trade fair, cannot lead to a claim for recourse against the organiser. Legal recourse is excluded.
13. Admission control and security services are provided by the trade fair organisation. The exhibitor is responsible for supervising and monitoring the exhibition stands. This also applies to set-up and dismantling times. The trade fair organisation accepts no liability for damage or loss.
14. The distribution of brochures and advertising material outside the rented areas is strictly prohibited. The use of radio and phono equipment and loudspeaker announcements is also prohibited. Photographic recordings by third parties for commercial purposes or drawings are only permitted by the organiser.
15. Additional services requested, such as a higher power connection, water, etc., are possible and will be invoiced separately to the exhibitor.
16. The right to sell food and drink as well as refreshments, confectionery and luxury foods of all kinds must be agreed exclusively with the organiser. We kindly ask you to contact the organiser if required.
17. The place of jurisdiction for all legal matters is Kufstein. This shall also apply to claims asserted in legal dunning proceedings, even if the lessee is a registered trader or a person under public law or has no general place of jurisdiction in Austria.
