



## Haflinger Performance Test

### Achievement test model – Haflinger

(The official version is german only. The translation is only inofficial and is to help to understand the german version.)

#### 1. Mares: Field test

- 1-day test by owner
- Test by a judge of the international Riding and Driving Association (80%) and an international Haflinger judge (20%)
- Exercise R1 in riding (FEI exercise) (40%)
- Exercise F1 in driving (FEI exercise) (40%)
- Personality test– harnessing, saddling before the judges, and examination of shoeing suitability (lifting of all four hooves) (20%)
- Test may be repeated within one year
- Separate riding and driving tests may be performed within one year
- Minimum age of horse – 3 years
- Mares from an age of 4 years, 5% point departure.

#### 2. Stallions: Test carried out in a test centre

- Riding and driving during the same two-day period
- Exercise R1 in riding (FEI exercise)
- Exercise F1 in driving (FEI exercise)
- Two-day test, which may be repeated if the candidate fails in any area. In this case, however, the whole test must be repeated; it is not possible to separate riding and driving.
- Minimum age of stallion – 3 years. Although there is currently no upper age limit, until several stallions have been tested it is recommended that the stallion does not exceed 6 years of age.
- Stallions from an age of 4 years, 5% point departure.
- The stallions have to be 30-days together in the training-centre with daily written comments

#### 1<sup>st</sup> part of test riding:

- Riding Exercise R1 by the owner (or a person appointed by the owner). Evaluation by an FEI-accredited judge of the national Riding and Driving Association (80%) and an international Haflinger judge (20%). Proportion of riding result: 50%
- Riding by an FEI-accredited judge of the national Riding and Driving Association (80%). Evaluation also by an international Haflinger judge (20%). Proportion of riding result: 50%.

**2<sup>nd</sup> part test driving:**

- Driving Exercise F1 by the owner (or person appointed by the owner). Evaluation by an FEI-accredited judge of the national Riding and Driving Association (80%) and an international Haflinger judge (20%). Proportion of driving result: 50%
- Driving by an FEI-accredited judge of the national Riding and Driving Association (80%). Evaluation also by an international Haflinger judge (20%) Proportion of driving result: 50%.

**3<sup>rd</sup> part test personality test:**

- Harnessing, saddling before the judges, riding and driving behaviour during the trial and examination of shoeing suitability (lifting of all four hooves). (FEI-accredited judge 50%, international Haflinger Judge 50%) Proportion of overall result: 20%

The experts judge the features in accordance with the generally recognised rules for riding and driving using the following grading system:

10 = excellent	5 = sufficient
9 = very good	4 = insufficient
8 = good	3 = fairly bad
7 = fairly good	2 = bad
6 = satisfactory	1 = very bad or not performed

5,0 – 5,9	-	sufficient
6,0 – 6,5	-	satisfactory
6,6 – 7,0	-	good
7,1 – 7,5	-	very good
7,6 -	-	excellent
