

Int. Judges World Haflinger Federation

Regulations of the world World Haflinger Federation for the admission into the international judge list:

The training of the judges is done by the individual member countries. Judges must be experienced Haflinger people before they start their first year of judging. Basic conditions is the fact that the judges and judge candidate are national judges with judging of national shows for five years and each second year visits an international judge training course, and additionally at least twice every year judging of national inspection or a national show, as well as every other year judging once international.

Each judge candidate must be suggested in writing by his national federation including all the informations about the personal judging experience including the show, exact date, number of horses and team of judges.

This 5 years national judge must be appropriate proofed by the World Haflinger Federation. After examination of these documents the World Haflinger Federation executive committee decides on an admission as a judge candidate.

If the candidate is approved by the general assembly, following criterias are to be fulfilled:

The candidate must participate within 2 years at least once per year in a judge training course of the World Haflinger Federation and judge 2 times together with an international judge that is nominated by the president, who has then to write minutes to the executive committee of the World Haflinger Federation. Of course the candidate has to judge a national inspection or a national show beside that, at least 2 times per year in his own country or another World Federation Member-Country. .

After this procedure the World Haflinger Federation can put the name on the international judging list.

All international judges must judge at least twice every year a national inspection or show and each second year visit an international judge training course and each second year judging a international show or inspection. A international Judge also has to judge a minimum of 200 horses a year.
